

ACL Releases New Brief on Importance of Oral Health

Good oral health is critical for older adults and younger adults with disabilities. Poor oral health is largely preventable and linked to a person's overall health and serious chronic diseases. Unfortunately, older adults and adults with disabilities are at high risk of having poor oral health due to inadequate access to services and certain disabilities that make oral hygiene tasks hard to complete and obtaining services even more difficult.

While Medicare does not cover most oral health services, states have a number of options for expanding oral health, as this [policy brief](#) describes.

Publicly-funded dental preventive and treatment services for adults are sparse because Medicare covers only a few medically-related dental procedures. Additionally, many state Medicaid programs have little dental coverage for adults. Some funding for oral health is available under the Public Health Service Act through the Health Resources and Services Administration's Community Health Centers Program. The 2016 Older Americans Act Reauthorization added oral health to the list of its disease prevention and health promotion services.

Throughout the past year, ACL [has shared profiles and promising practices from employment service providers](#) working with people with disabilities across the country. Many of the providers described their experiences transitioning from a sheltered workshop to more integrated community-based models.

For National Disability Employment Awareness Month, we've compiled the many tips, strategies, and leverage points that providers identified as critical to their success.

These include tips for planning, cultivating partnerships and funding, staffing, and supporting beneficiaries:

- Take small incremental steps to build infrastructure and slowly reallocating resources.
- Stay connected to other providers who have either gone through, or are undergoing, the same transformative change. Learn from each other.



- Optimize funding mechanisms, policy levers, and incentives. This includes federal grants from the U.S. Departments of Labor and Health and Human Services as well as funding from Vocational Rehabilitation (VR) and Medicaid.
- Talk to staff early and frequently about the business model change and reassure them that the plan is not to fire them.
- Adapt services to meet each person's specific needs. The more individualized the support, the more likely there is a successful employment outcome.

The Center for Health Care Strategies (CHCS) has put out a request for applications to the State Oral Health Leadership Institute (SOHLI), a 12-month professional development program for pairs of state Medicaid dental program directors and state oral health program directors.

Webinar: Measurement Based Care Techniques

Relias Learning is hosting a webinar about using measurement based care techniques for integrating behavioral health into primary care. A critical component to success for programs that attempt to integrate behavioral health into primary care settings is the use of measurement based care (MBC) principles. In the same manner that diabetes and hypertension management involve screening for the condition, measuring the severity, and using metrics to measure for improvement, MBC uses validated instruments to measure the severity of mental health and substance use symptoms to provide quantitative clinical feedback regarding progress or lack of progress that is used to drive treatment decisions about medication changes, therapeutic interventions, referrals, and other recommendations. MBC enables the treat-to-target approach that is familiar for other primary care conditions. CMS

CMS Announces a New Funding Opportunity for Track 1 of the Accountable Health Communities Model

CMS, in January 2016, released a new Funding Opportunity Announcement (FOA) for a model called the Accountable Health Communities (AHC). This Center for Medicare & Medicaid Innovation model focuses on the health-related social needs of Medicare and Medicaid beneficiaries. The AHC Model is based on emerging evidence that addressing health-related social needs through enhanced clinical-community linkages can improve health outcomes and reduce costs. The original FOA requested applications for three different scalable tracks featuring interventions of varying intensity that would address health-related social needs for beneficiaries. After receiving inquiries and stakeholder feedback, CMS has decided to make modifications to the Track 1 application requirements and is releasing a new FOA specific to Track 1 of the AHC Model. Track 1 will support bridge organizations to increase a patient's awareness of available community services through screening, information dissemination, and referral. Track 1 award recipients will partner with the state Medicaid agency, community service providers and clinical delivery sites to implement the Model. The modifications to the Track 1 application include the following: (1) Reducing the annual number of beneficiaries applicants are required to screen from



75,000 to 53,000; and (2) Increasing the maximum funding amount per award recipient from \$1 million to \$1.17 million over 5 years.

Under this announcement, CMS is accepting applications from community-based organizations, health care practices, hospitals and health systems, institutions of higher education, local government entities, tribal organizations, and for-profit and non-profit local and national entities with the capacity to develop and maintain relationships with clinical delivery sites and community service providers. All applicants, including those who applied to Tracks 1, 2 or 3 in the previous FOA, are eligible to apply to this FOA.

Applicants that previously applied to Track 1 of the AHC Model under the original FOA (# CMS-1P1-17-001) must re-apply using this FOA (# CMS-1P1-17-002) to be considered for the Model.
